REQUEST FOR PROPOSAL

The Husted Fire Department, 6215 Springfield-Xenia Rd., Springfield, Ohio 45502, **UNTIL FRIDAY, DECEMBER 19, 2008 AT 12:00 P.M.**, will receive sealed bids for one Pumper Tanker apparatus and auxiliary equipment per the specifications. **PLEASE NOTE: BIDS DELIVERED / RECEIVED AFTER THE SUBMITTAL TIME (EXACTLY 12:00 P.M. ON THE DEPARTMENT'S CLOCK) WILL NOT BE ACCEPTED.** Specifications and bid / contract forms and other documents may be picked up at the Husted Fire Department, 6215 Springfield-Xenia Rd., Springfield, Ohio 45502.

Each bid shall contain the full name and address of each person or company submitting the bid. All bids must be submitted to the Husted Fire Department, 6215 Springfield-Xenia Rd., Springfield, Ohio 45502 **NO LATER THAN FRIDAY, DECEMBER 19, 2008 AT 12:00 P.M.** Bids will be opened at approximately 1:00 P.M. on Friday, December 19, 2008 in the Husted Fire Meeting Room at 6215 Springfield-Xenia Rd., Springfield, Ohio 45502. Bids will be clearly marked on the outside of the envelope in the lower left hand corner as "Pumper Tanker Bid". The name and address of the bidder must also appear on the outside of the envelope.

Each bid must have a performance bond included in the proposal price. The bond must be in the department's possession within ten (10) days after award of the contract.

Attention of the bidders is called to the following: Proposals will only be considered from companies which have established a favorable reputation in the field of fire apparatus construction. A customer listing of like units in service and their location; the location of the closest factory representative in proximity to department; the manufacturer's closest factory staffed facility to Customer; and documentation of the length of time manufacturing aluminum fire apparatus bodies are to be included and returned with the bid. **PLEASE NOTE:** the Township is exempt from all Federal, State, Local, and / or Excise Taxes.
